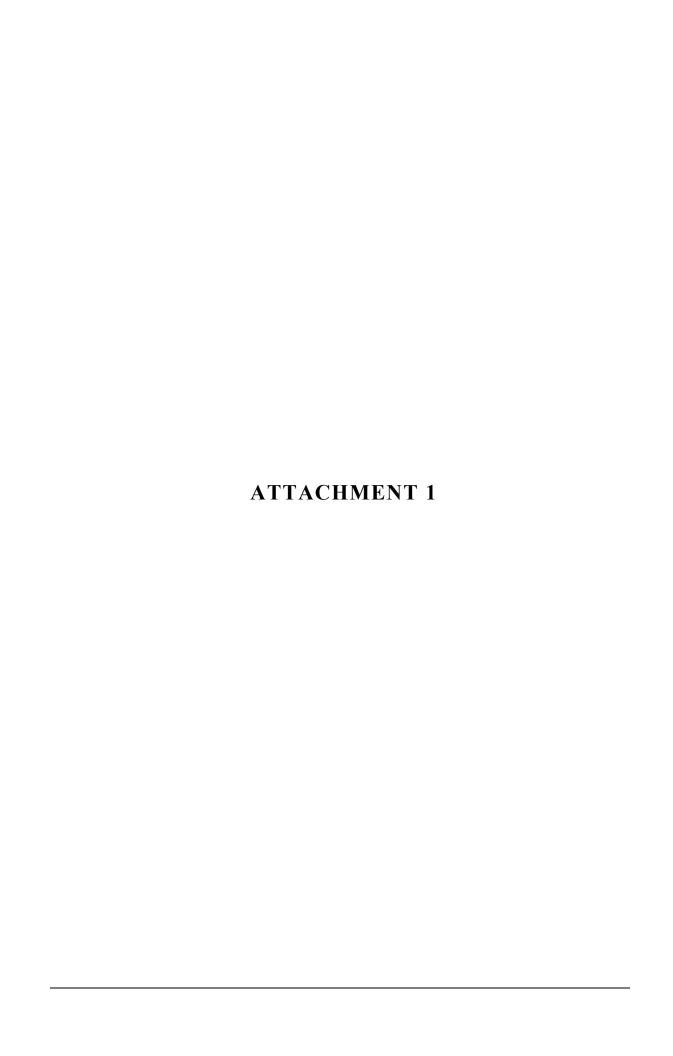
Background/Discussion

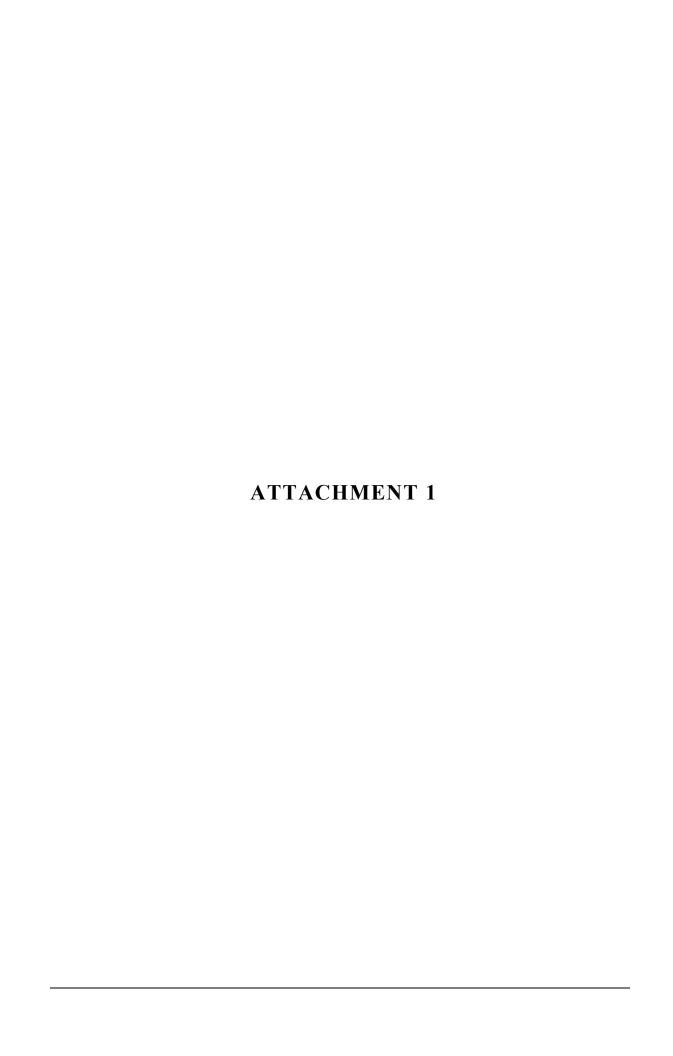

Action Requested

Staff requests that the Board of Directors approve Resolution R09-2020 authorizing the Executive Director to execute an initial Memorandum of Understanding ("MOU") with the San Joaquin Regional Rail Commission ("SJRRC") to establish the process and roles and responsibilities in managing the operations of future Valley Link Service plus and further documents related to the MOU and SJRRC support to the Project.

Background

At its November 18, 2020 meeting, the TVSJVRRA ("Authority") Board Directors received an informational report from staff to bring on SJRRC as the agency to manage operations of the Valley Link operations and to provide immediate input during the Project's upcoming planning phases. During the discussion portion of this agenda item, numerous Board Directors voiced their support for this proposal.

In addition, at the December 1, 2020 the Valley Link Executive Steering Committee ("ESC"), the members enthusiastically supported this proposal to bring SJRRC on to the Valley Link Project Team and the SJRRC Board, at its December 4, 2020 meeting, authorized the SJRRC Executive Director to execute the MOU with the Authority.

Discussion

As presented at the Authority's November 18, 2020 Board Meeting, SJRRC brings the following key accomplishments and expertise to the Valley Link Project Team:

- An exemplary safety record in managing the operations of both the ACE commuter rail service (over 20 years) and the Amtrak San Joaquins (for over 7 years)
- Extensive development of all aspects of transit service from procuring a contracted operator to developing specifications for various transit vehicles to preparing various regulatory safety and security operating plans.
- Excellent working relationships with Union Pacific Railroad, Federal Railroad Administration and Federal Transit Administration, CalSTA/Caltrans, and local and regional agencies throughout the San Joaquin Valley

Another benefit to the Authority is the immediate and efficient access to the SJRRC resources rather than have the Authority go through a more time-consuming process to develop a new separate individual operating agency for Valley Link.

This experience and knowledge base from the SJRRC will be vital the Authority as the Draft Environmental Impact Report (EIR) has been released and efforts will soon begin on the Preliminary Engineering (PE) phase of the Project (30% design plans, specifications for procuring rail vehicles, et al),

The Authority and the SJRRC have discussed the potential advantages of designating the Commission as the Operating Agency for Valley Link and desire to enter into this MOU for the purposes of memorializing the understanding of the Authority and SJRRC establishing a framework to negotiate agreements establishing their roles and responsibilities for the successful implementation and operation of the new service.

Key points from the MOU include:

- The Authority is established as the Owner of the Valley Link service and is responsible for all governance and project funding, policies, planning, development, implementation and service decisions.
- The Authority is interested in designating an Operating Agency early in the Valley Link project delivery to provide input into project development and achieve safe, efficient and cost-effective operations.
- SJRRC has the expertise and a successful track record to perform the services of an Operating Agency to work under the direction of and to support the Authority in its' goals for Valley Link service.
- The roles and responsibilities for the Operating Agency will be defined in agreements established though an iterative process where the Authority and SJRRC evaluate those details at regular milestones throughout the project development process.
- It is anticipated that following negotiations, detailed agreements will be executed as the Valley Link project moves toward implementation.

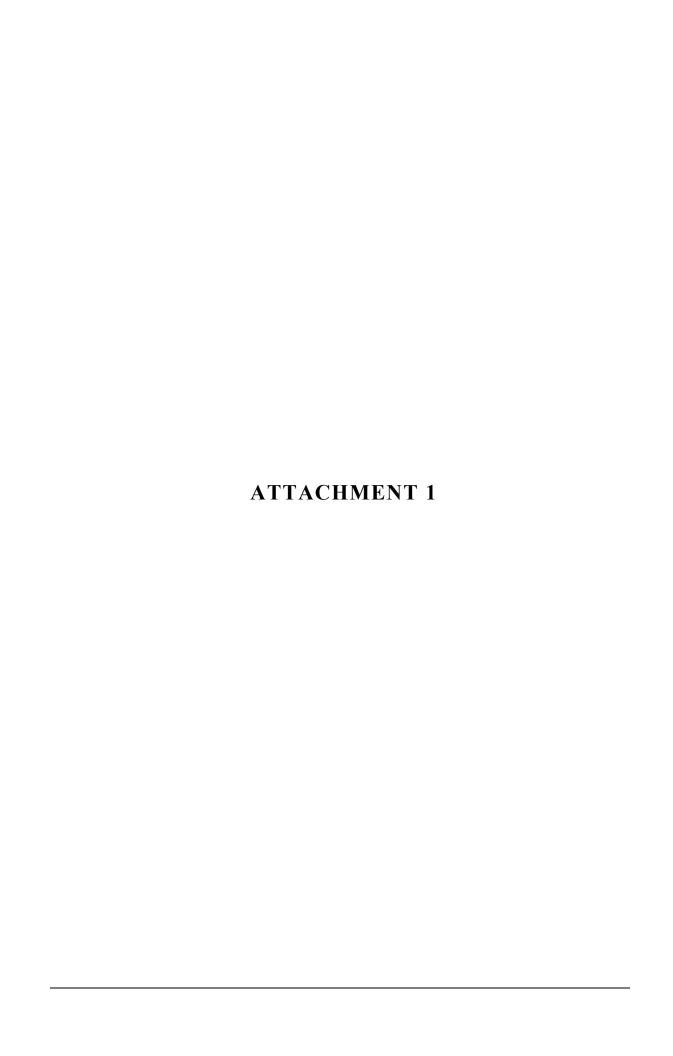
Staff is requesting the Authority Board to approve the attached resolution which approves this initial nonbinding MOU with the Authority with a goal of the SJRRC serving as the agency that would be responsible for Valley Link operations.

Fiscal Impact

The Board's adoption of Resolution R08-2020 at its November 18, 2020 meeting set aside \$300,000 from the Authority's receipt of \$46.8 million from MTC at its June 24, 2020 Commission meeting (Resolution R02-2020) for SJRRC's activities identified within the MOU and any related documents during the period of January 2021 to June 2022.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE TRI-VALLEY-SAN JOAQUIN VALLEY REGIONAL RAIL AUTHORITY AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE TO EXECUTE AN INITIAL MEMORANDUM OF UNDERSTANDING (MOU) WITH THE SAN JOAQUIN REGIONAL RAIL COMMISSION ("SJRRC") TO ESTABLISH THE PROCESS AND ROLES AND RESPONSIBILITIES FOR MANAGING THE OPERATIONS OF THE FUTURE VALLEY LINK SERVICE AND AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE ANY AND ALL DOCUMENTS RELATED TO THE PROJECT

WHEREAS, the Legislature adopted AB 758 (2018), establishing the Tri-Valley–San Joaquin Valley Regional Rail Authority (Authority) under California Public Utilities Code Section 132651 *et seq.*, to plan, develop and deliver cost-effective and responsive transit connectivity between the Bay Area Rapid Transit District's rapid transit system in the Tri-Valley and the Altamont Corridor Express commuter rail service (the "Valley Link Project" or "Project");

WHEREAS, pursuant to AB 758, the Authority prepared and delivered an initial Project Feasibility Report to the Legislature by June 30, 2019 to explore the improvement of transit connectivity between the Tri-Valley and San Joaquin Valley;

WHEREAS, the Authority, in conjunction with the final Project Feasibility Report, has been engaged in the design and environmental activities to advance the Valley Link Project towards construction and eventual operation;

WHEREAS, SJRRC is a project partner for the Authority and has been a supporter of the Valley Link Project since its inception; and

WHEREAS, SJRRC has partnered with the Authority to develop and advocate for a shared vision for the Altamont Corridor that includes coordinated and integrated Valley Link and Altamont Corridor Express ("ACE") services; and

WHEREAS, SJRRC has extensive experience in the development of all aspects of a new passenger railroad service and is the managing agency for the operations of the ACE and San Joaquin train services providing service between the San Joaquin Valley and Alameda County that overlaps with the Valley Link service area; and

WHEREAS, SJRRC and Authority staff have discussed the potential advantages of designating the SJRRC as the Operating Agency for Valley Link and desire to enter into this MOU (see attached) for the purposes of establishing a framework to negotiate agreements establishing their roles and responsibilities for the successful implementation and operation of the Valley Link Service; and

WHEREAS, SJRRC and the Authority desire to memorialize in this non-binding MOU, their shared commitment to negotiate agreements establishing the roles and responsibilities for the SJRRC as the Operating Agency and for the SJRRC to provide input in project development at the request of the Authority; and

WHEREAS, this MOU contemplates an iterative and collaborative process, leading the SJRRC, and the Authority to negotiate and ultimately enter into detailed agreements as the Valley Link Service moves forward toward implementation.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Tri-Valley-San Joaquin Valley Regional Rail Authority hereby authorizes the Executive Director to execute the attached Initial Memorandum of Understanding (MOU) with the San Joaquin Regional rail Commission (SJRRC) to establish the process and roles and responsibilities for managing the operations of the future Valley Link Service and authorizing the Executive Director to execute any and all documents related to the Project.

MEMORANDUM OF UNDERSTANDING BY AND BETWEEN THE TRI-VALLEY – SAN JOAQUIN VALLEY REGIONAL RAIL AUTHORITY and SAN JOAQUIN REGIONAL RAIL COMMISSION

TO ESTABLISH THE PROCESS AND ROLES AND RESPONSIBILITIES FOR MANAGING THE OPERATIONS OF THE FUTURE VALLEY LINK SERVICE

This Memorandum of Understanding (MOU) is entered into by and between the Tri-Valley – San Joaquin Valley Regional Rail Authority and the San Joaquin Regional Rail Commission (referred to herein collectively as the "Participants") to facilitate coordination in establishing the roles and responsibilities of an Operating Agency for the Valley Link Service to serve under the direction of the Authority.

PERTINENT ENTITIES

Tri-Valley – San Joaquin Valley Regional Rail Authority (Referred to in this MOU as "Authority" or "Owner"): the agency responsible for the governance, planning, implementation, operation and maintenance of the future Valley Link rail service.

San Joaquin Regional Rail Commission (Referred to in this MOU as "Commission" or "Operating Agency"): the agency responsible for the governance, operation and maintenance of the Altamont Corridor Express (ACE) and the current managing agency of the San Joaquins intercity passenger rail service under the direction of the San Joaquin Joint Powers Authority (SJJPA).

GENERAL BACKGROUND

The Authority was established through the enactment of Assembly Bill 758 (Eggman) to plan and deliver the Valley Link project – a critically needed, mega-regional, rail connectivity project to link Livermore and the Central Valley to the Dublin/Pleasanton BART station. This service will also connect to the ACE east-west trunk line and the new north-south ACE expansion between Merced and Natomas.

This single purpose Authority is necessary to accelerate Valley Link project delivery to accommodate the dramatically increasing travel demand along the I-205 and I-580 corridors, and to provide policy representation and governance for Alameda and San Joaquin County constituents.

The mega-region has struggled with numerous individual agencies operating independent transit services that lack integration and coordination with each other and many stakeholders have expressed a desire for the Authority to work with an existing agency to oversee operations rather than evolving into another fully-staffed operating entity. The early identification of an operating agency will assist the Authority with certain milestone decisions that could affect the viability, scope or cost of future operations.

The Commission has overseen the start-up and 22 years of ongoing ACE Service operations and is experienced with all aspects of day to day passenger rail service oversight and the operating regulatory environment. The Commission was also selected through a competitive process to provide day to day oversight of the Amtrak San Joaquins based upon this expertise and a knowledge of travel patterns and the communities between the Central Valley and the Bay Area. The San Joaquin Joint Powers Authority provides all policy direction related to the San Joaquins.

The Authority and the Commission have discussed the potential advantages of designating the Commission as the Operating Agency for Valley Link and desire to enter into this MOU for the purposes of memorializing the understanding of the Authority and Commission establishing a framework to negotiate agreements establishing their roles and responsibilities for the successful implementation and operation of the new service.

RECITALS

- A. Whereas, the Authority is established as the Owner of the Valley Link service and is responsible for all governance and project funding, policies, planning, development, implementation and service decisions; and
- B. Whereas, the Authority is interested in designating a presumptive Operating Agency early in the Valley Link project delivery to provide input into project development for the purposes of achieving safe, efficient and cost-effective operations; and
- C. Whereas, the Commission has the expertise and a successful track record to perform the services of an Operating Agency to work under the direction of and to support the Authority in its' goals for Valley Link service; and
- D. Whereas, the Commission is already a project partner and supporter of the Valley Link service, and is a member of the Valley Link Executive Steering Committee (ESC); and
- E. Whereas, the joint plans for Valley Link and ACE service across the Altamont Corridor are complementary; and
- F. Whereas, at its November18, 2020 meeting, the Authority authorized its Executive Director to enter into a cooperative agreement with the Commission in order to reimburse the Commission's costs directly related to the development of service operating plans for the Valley Link Project; and
- G. Whereas, the Participants desire to memorialize in this non-binding MOU their shared commitment to negotiate agreements establishing the roles and responsibilities for the Commission to provide input in project development at the request of the Authority as the presumptive Operating Agency and to consider an arrangement for the Commission to serve as the Operating Agency (collectively "Objectives"); and
- H. Whereas, this MOU contemplates an iterative and collaborative process, leading the Participants to negotiate and ultimately enter into detailed agreements to accomplish the Objectives as the Valley Link service plans develop.

NOW, THEREFORE, THE PARTICIPANTS SHARE THE FOLLOWING UNDERSTANDING:

- 1. The Authority is currently engaged in the Valley Link project development process and has a dedicated staff and consultant teams undertaking this effort.
- 2. The Authority has designated the Commission as the presumptive Operating Agency, to serve under the direction of the Authority/Owner for managing the ultimate Valley Link operations.
- 3. As the Valley Link program moves through the various stages of project development, there may be decisions where the Authority seeks input from the Operating Agency to ensure the most efficient and safe future operations.
- 4. The Commission has experience implementing new passenger rail service and would be able to provide input when requested by the Authority.
- 5. The roles and responsibilities for the Operating Agency will be defined in agreements established through an iterative process where the Participants evaluate those details at regular milestones throughout the project development process.
- 6. The Participants agree to collaborate, cooperate and coordinate with each other, including their respective staff and/or consultants, to achieve the Objectives of this MOU.
- 7. An Ad Hoc Committee of Board Members from the Authority and the Commission may be convened periodically to explore issues related to establishing the Objectives of this MOU.
- 8. At a minimum, in January and July of each year, the Participants will meet to jointly develop more refined iterations of the roles and responsibilities for discussion and direction from their respective Governing Boards.
- 9. It is anticipated that following negotiations, detailed agreements will be executed as the Valley Link project moves toward implementation.

NON-BINDING MOU

- a. This MOU is a non-binding, voluntary initiative and does not create any legally binding rights, limitations or obligations upon the Participants. This MOU does not purport to include all provisions relative to the structure or terms of the proposed transaction or definitive documents. Rather, the Participants agree that any binding commitments in future will be memorialized in agreements as they are negotiated. Each party shall bear its own costs related to this effort unless otherwise agreed in writing.
- b. Should the Participants reach an impasse in the collaborative effort anticipated by this MOU, the contact points (identified above) will make an expeditious and good faith effort at working together to resolve the impasse. Should that effort be unsuccessful, the Participants agree to elevate the outstanding issues to their respective Chief Executive Officer/Executive Director/Secretary who will then make an expeditious and good faith effort at working together to resolve the impasse.
- c. This MOU is not intended to amend or impact in any way other existing written agreements or MOUs that Participants may have entered pertaining to ACE or the Valley Link project, in general.
- d. This MOU is effective from the date of its last signature and shall remain in effect until another MOU or agreement is executed between the Participants, or one Participant withdraws from the MOU, whichever is earlier.
- e. The Participants may, at any time, withdraw from this MOU by providing a written notice to the other Participant.
- f. This MOU may be executed in two or more counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one and the same instrument. Facsimile, pdf., or electronic/computer-image signatures will be treated as originals.

SUBJECT: Approving Option Contract Term Sheet to Acquire 200 Acres (APNs 209-230-029 and

209-230-030) from the City of Tracy for a Potential Future Operations and Maintenance

Facility and Authorizing the Executive Director to Execute the Term Sheet

Action Requested

Staff requests that the Board of Directors (Board) approve Resolution R10-2020, approving an option contract term sheet to establish the framework of an option transaction that will provide Valley Link with the ability to acquire 200 acres of property in Tracy and authorizing the Executive Director to execute that term sheet.

Background/Discussion

The Feasibility Report for the Valley Link project, as well as the recently-released Draft Environmental Impact Report both identified a location in the City of Tracy as a potential site for an Operations and Maintenance Facility (O&M Facility). Valley Link approached the City about the site, which consists of two City-owned parcels totaling approximately 200 acres (APNs 209-230-029 and 209-230-030) (the "Property"). The parties have negotiated a term sheet for an option contract (Attachment 1) for the conveyance of the Property, which would not occur unless the location is included in the adopted project.

The parties have discussed entering into an option contract through which Valley Link will be granted an exclusive and irrecoverable option to "purchase" the Property as an in-kind contribution from the City towards the Project, subject to certain conditions (the "Option Contract"). Acquisition of the property will enable the Authority to use the property as the local match for potential federal grant funding. The proposed term sheet reflects the parties' understanding of the basic terms for the Option Contract, which will be negotiated and executed in the future. The following are key provisions of the proposed Option Contract, as reflected in the non-binding term sheet:

- City will grant an exclusive and irrevocable option to Valley Link to purchase the Property.
- Purchase Price: No cost to Valley Link. The value of the Property will be considered an in-kind contribution by the City to Valley Link to be leveraged for additional grant funding.
- Term of Option Contract: 10 years. Valley Link may only exercise option to purchase the property
 after the EIR has been adopted and the Property has been selected as the location for the O & M
 Facility.
- Consideration for Option: \$100 upon execution of the Option Contract.
- Reversion to City: If site is not used by the Valley Link Project within 10 years of the purchase date the property shall revert to the City. This provision is subject to review by federal-grant making agencies to ensure compliance with grant requirements for a local match.
- Non-Binding: The term sheet is non-binding, but provides the framework for negotiation of a binding Option Contract that will be brought to the Board for approval.

This item also requests that the Board authorize the Executive Director to execute the term sheet.

Fiscal Impact

As the term sheet is not binding, there is no fiscal impact from this action. Legal counsel will negotiate the Option Contract, which provides for a minimal payment to the City for the option.

Recommended Action

Approve an option contract term sheet to acquire 200 acre parcel from the City of Tracy and authorize the Executive Director to execute the term sheet.

OPTION CONTRACT TERM SHEET

This Option Contract Term Sheet ("**Agreement**") sets forth the basic terms and conditions upon which the City of Tracy ("**Seller**") agrees to conveying to the Tri-Valley–San Joaquin Valley Regional Rail Authority ("**Buyer**") the real property commonly referred to as 15580 and 15178 W. Schulte Road (APNs 209-230-29 and 209-230-30) in the City of Tracy, County of San Joaquin, State of California (the "**Property**"), which is described in Exhibit A, attached hereto and incorporated herein by this reference. Buyer and Seller are referred to individually as a "Party" and together as "the Parties,"

Upon mutual assent of the Parties, a binding Option Contract and Purchase and Sale Agreement ("**Option Contract**") will be prepared based on the terms and conditions contained herein.

- **1. Grant of Option** Seller will grant to Buyer, for the Option Term, an exclusive and irrevocable option ("**Option**") to purchase the Property under the terms of the Option Contract if and when such Option is exercised.
- **2. Option Payment** The grant of such Option is conditioned upon the payment by Buyer of \$100 within 30 days after Execution of the Option Contract.
- **Term of Option** The term of the option will commence on the Effective Date of the Option Contract and expire 10 years after that Effective Date.
- 4. Memorandum of Option

 Buyer and Seller shall execute and record in the Official Records of the County of San Joaquin a Memorandum of Option Agreement within 10 days after the Effective Date of the Option Contract. If the Option becomes null or void, Buyer shall record a Quitclaim Deed and take any further actions necessary to remove any cloud on title due to the recordation of the Memorandum of Option.
- **5. Compensation** Buyer shall pay no cash compensation for the Property. Transfer of the Property is intended to partially offset the contribution of Bay Area transportation agencies to the Valley Link Project.
- 6. Exercise of Offer The Option must be exercised by Buyer, if at all, by giving notice of its exercise of the Option ("Exercise Notice") but only when Buyer shall have adopted a final environmental impact report for the Valley Link project and the selected alternative includes use of the Property or these conditions are waived in writing by Seller.
- 7. **Due Diligence**Buyer will have a period of ninety (90) days from the date it delivers the Exercise Notice to Seller to complete all necessary due diligence ("**Due Diligence Period**"). Seller will provide the due diligence materials in Seller's possession within five (5) business days of the date of the delivery of the Exercise Notice. Seller will also promptly provide to Buyer such additional materials as Buyer may reasonably request from time to time during the Due Diligence Period. The Option Contract will grant to Buyer a right of entry to enter onto the

Property during the Due Diligence Period for all necessary due diligence purposes, but require Buyer to indemnify Seller for liabilities arising from its investigations, to carry appropriate insurance, and to maintain confidentiality. Each party will bear its own costs in connection with due diligence and negotiation of this Agreement and the Purchase and Sale Agreement. If Buyer is unsatisfied with the results of its due diligence review before the end of the Due Diligence Period, it may terminate the Purchase and Sale Agreement. Buyer may, at its cost, perform additional studies on the Property, including, but not limited to, a Phase I or Phase II environmental report, as Buyer deems necessary or desirable and Seller shall provide Buyer and Buyer's consultants with reasonable access to the Property for this purpose.

8. Purchase and Sale Agreement

Within thirty (30) business days of acceptance of this Agreement, Buyer will deliver to Seller or Seller's counsel a first draft of the Option Contract that shall contain provisions, representations and warranties related to the real property as customarily provided. The Option Contract shall include a term providing that once the Property is acquired, it will revert to the City in the event the Property is not used by for the Valley Link Project within 10 years of the purchase date. The specific wording of this term shall be subject to review by federal grant-making agencies to ensure it will not interfere with the use of the property as the local match for potential federal aid for the Valley Link Project.

9. Closing Conditions

The closing will be contingent upon due diligence approval before the end of the Due Diligence Period.

10. Title/Survey

The Owner's Title Policy shall be obtained through a nationally recognized title company determined by Buyer. Buyer, at its election and cost, may obtain an ALTA survey for the Property. Buyer shall also pay the costs of any fees for the title search, title commitment, owners' title policies (with extended coverage), and the cost of any other endorsements or lender's title policies. At closing, Seller shall convey to Buyer good and marketable fee simple title to the real property by grant deed.

11. Closing Date

The closing shall occur on or before 60 days following expiration of the Due Diligence Period, provided all conditions to close have been met at least five (5) business days prior ("Closing Date").

12. Brokers' Fees

Each party represents to the other that it has not engaged or otherwise involved a broker to represent its interests in connection with this transaction. Each party will indemnify, defend, and hold harmless the other party from and against any costs, expenses, and liabilities

arising from a breach of the foregoing representation.

13. Expenses

Each party will bear their own expenses associated with this Agreement, the acquisition and other transactions contemplated herein, including, without limitation, legal, accounting, due diligence and other fees and disbursements of consultants and advisors.

14. Non-Binding

All terms and conditions of this Agreement are not legally binding and do not constitute a binding agreement on either party hereto, or even an obligation to negotiate further in good faith, but rather are intended to serve as reflection of the parties' preliminary understanding of terms to consider in negotiation of a binding agreement. Neither party may claim any legal rights against the other by reason of signing of this Agreement or by taking any action in reliance thereon.

This Agreement will be construed and enforced in accordance with the laws of the State of California, without regard to the conflict of law provisions thereunder. This Agreement may be executed in one or more counterparts and exchanged electronically by .pdf.

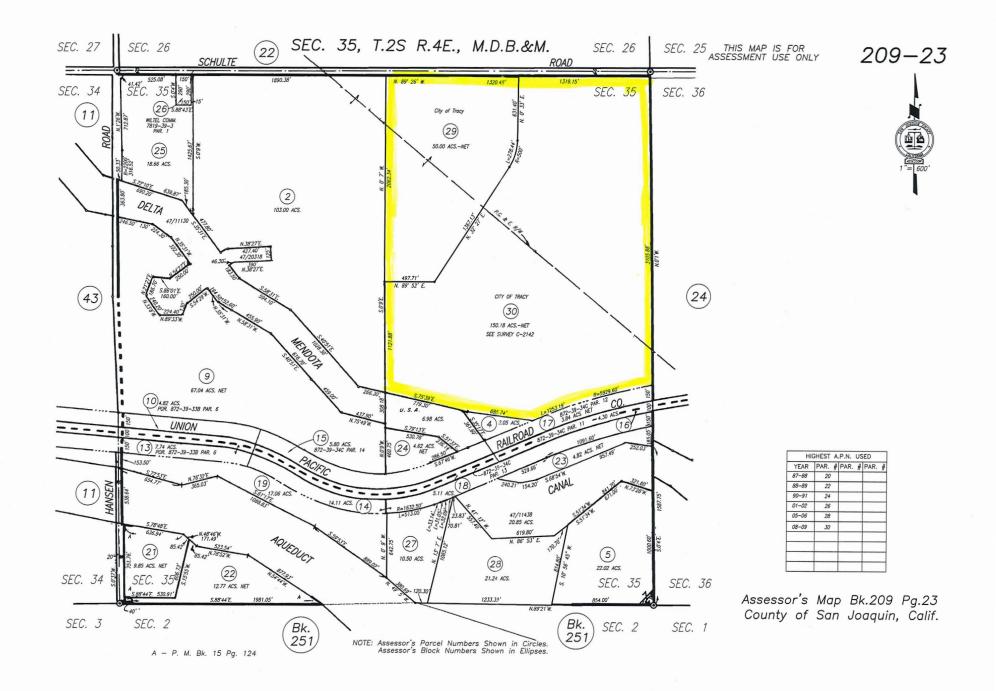

WHEREAS, the Legislature adopted AB 758, establishing the Tri-Valley-San Joaquin Valley Regional Rail Authority (Authority) under California Public Utilities Code Section 132651 *et seq.*, to plan, develop and deliver cost-effective and responsive transit connectivity between the Bay Area Rapid Transit District's rapid transit system in the Tri-Valley and the Altamont Corridor Express commuter rail service:

WHEREAS, as required by AB 758, the Authority prepared and delivered an initial Project Feasibility Report (Feasibility Report) to the Legislature on June 30, 2019 to explore the improvement of transit connectivity between the Tri-Valley and San Joaquin Valley; and

WHEREAS, pursuant to the final Feasibility Report, the Authority has been engaged in the design and environmental activities to advance the Valley Link Rail Project (Project) towards construction and eventual operation; and

WHEREAS, the Feasibility Report and the recently issued Draft Environmental Impact Report have identified a property in the City of Tracy (City) as a potential location for a future Valley Link operations and maintenance facility ("O&M Facility"), and

WHEREAS, Valley Link approached the City about two City-owned parcels totaling approximately 200 acres (APNs 209-230-029 and 209-230-030) (the "Property"), as a potential site for the O&M Facility, and

WHEREAS, the parties have negotiated a term sheet for an "option contract" that will grant

Valley Link an exclusive and irrecoverable option to purchase the Property at no cost and as an in-kind contribution from the City, subject to certain conditions, and

WHEREAS, the Property could be used as a "local match" to leverage future federal grant funds, should such funds become available.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Tri-Valley-San Joaquin Valley Regional Rail Authority hereby approves the Option Contract Term Sheet presented to the Board on this date and authorizes the Executive Director to execute the Term Sheet on behalf of the Authority.
