Tri-Valley San Joaquin Valley Regional Rail Authority (TVSJVRRA) Minutes of May 13, 2020 Meeting via Zoom Teleconference

1. Call to Order and Pledge of Allegiance

Meeting was called to order by Board Chair Scott Haggerty at 2:06pm.

2. Roll Call of Members

3. Public Comments

Public comment was received from Roland Lebrun on difficulties accessing the meeting via phone.

4. Consent Calendar – ACTION

5. Executive Director's Report – INFORMATION

Executive Director Michael Tree updated the board on goings-on since the last board meeting in March where the reimbursement agreement with BART and AECOM Contract Addendum 2 were approved.

- On March 25 a \$3M allocation request was approved by the MTC board. This request funded the position
 of Program Manager and the work approved AECOM amendment. Tree commended Program Manager
 Ric Rattray on his work so far on the Valley Link project.
- Staff made a presentation to the SJ Partnership as the partnership plans for a possible Transportation Sales Tax in 2022.
- Many letters of support for Valley Link and the Altamont Corridor Vision have been received. Letters
 were sent to Chair Haggarty and MTC staff as they prepare the blueprint for Plan Bay Area 2050 for
 their commission to consider.
- Staff has incorporated into the environmental work CEQA an alternative catenary line in the Altamont section of the Valley Link Project. This would allow the trains to be powered by electricity from the catenary line and allow the batteries on board to be re-charged, thereby advancing the board's goal of 100% sustainability and operation of a zero-emission train.

- Meetings took place with Congressman Swalwell and Congressman Harder's staff about a potential stimulus infrastructure package in light of COVID-19 and how Valley Link would fit into it.
- On April 16 San Joaquin Council of Government (SJCOG) amended their Regional Transportation Plan to include Valley Link in the fiscally restrained section. Special thanks to Andrew Chesley, his staff and Directors Zuber and Elliot who also sit on the SJCOG board.
- On May 11 the Planning, Policy and Legislative Committee of Alameda County Transportation Commission (ACTC) met and unanimously agreed to forward to the full commission for consideration an amendment to the Transportation Expenditure Plan to include TVSJVRRA as an eligible recipient of Measure BB funds and also to transfer the \$400M that was for the BART to Livermore project into the Valley Link project. The committee will then open a 45-day comment period for member agencies and later bring an action item that would approve the amendments to the plan. Tree thanked Director Marchand, Mayor Haubert and Chair Haggarty for their efforts.
- A financial audit is being conducted, the report is expected to be completed in a few months. TVSJVRRA
 is involved in discussions with the City of Livermore and MTC as they consider additional Priority
 Development Areas within the Bay Area. The Southfront station is being looked at the project level and
 is in the area of an APD. Tree welcomed Candice Kendall, new Executive Assistant and re-introduced
 Ric Rattray, Project Manager for the Valley Link Project.

Chair Haggerty commented that in his role as Chair of MTC, he has created a Blue Ribbon Task Force to help guide MTC in the recovery of Bay Area transit networks as the region adjusts to new conditions created by the COVID-19 pandemic. The task force will discuss strategies to restore ridership and will be chaired by Solano County Supervisor Jim Spering.

No questions on Executive Director's report.

6. Economic Impact Study – INFORMATION

Chair Haggarty summarized the findings of the of the study and was very pleased that the analysis was completed. Haggarty commented on the number of jobs lost since the COVID-19 pandemic and the rising unemployment rate in the U.S. He stated the importance of keeping the Valley Link project moving forward and in position to receive any and all sources of recovery funding.

Executive Director Michael Tree noted that the study was completed at no cost to TVSJVRRA and introduced presenters Ron Wong and Marcia Sagami of PGH Wong.

Sagami described the tool used to conduct the study – a web-based tool developed by the American Public Transportation Association (APTA) that takes agency spending dollars and calculates how that money is further spent within the region. She then detailed the findings of the study stating the Valley Link project is expected to create 22,000 jobs with worker income of approximately \$1.35 billion, generate \$3.5 billion of local business sales. Operations will support approximately 400 jobs per year with labor income of over \$19M each year. The project is expected to generate \$69 million in business sales annually. Overall the project will not only have a phenomenal economic impact in the region but also provide an alternative to the congested corridor in the Tri-Valley area.

Directors discussed this item. PGH Wong staff to follow up on how the wine industry was categorized in the analysis.

Tree remarked that all feedback was valued, staff anticipated building this first edition of the model and having continued discussion on the output.

7. Track Design Plans to Optimize Performance of Valley Link Trains – INFORMATION

Executive Director Michael Tree stated that after the Feasibility Report was complete, and the Environmental Study began, it was realized that in 2040 the ridership on the San Joaquin side of the track would be at crush loads during the peak period with 12/24 headways. Staff committed to look at 12/12 headways throughout the first phase with passing lanes. LTK provided the modelling services, their presentation reflected the results.

LTK Consultant Thomas Matoff, assisted by Lisa Cobb provided a presentation to the board on the proposed track design plans. The analysis conducted answered the question of how Valley Link could provide effective two-way service on a single-track railroad and minimize running time. The solution will be to implement strategically placed passing sidings of full-service, full-speed sections of double track and avoid stop and wait situations. It was noted that no specific vehicle has been selected. An assumed candidate vehicle, the Stadler 3-car DMU, was used for planning and analysis purposes. Matoff detailed the findings of the modelling and presented animated illustrations of the route with proposed sidings and concluded it is a feasible railroad.

Directors discussed this item. Staff was asked to bring the following back to the board: estimates and modeling of ridership based on higher train frequency, economic impact of increasing the number of sidings, as well as the cost to double track the entire route.

Chair Haggerty asked for public comment.

Public comment was received from Roland Lebrun on functionality of Valley Transportation Authority (VTA) light rail.

8. Allocation Request to MTC – ACTION

Executive Director Michael Tree introduced Program Manager, Ric Rattray. Rattray reiterated his experience with projects of this nature and was pleased to be working with Valley Link Rail. Rattray summarized what project costs were funded by the monies received from Tier 0 and Tier 1 funding. The Tier 2 Allocation Request also known as the Project Development Phase, includes the 30% design, Caltrans Project Approval and Environmental Documentation (PA & ED), Federal environmental process – NEPA and hiring of expert staff. This work will allow the Valley Link project to be in a position to receive any upcoming funding opportunities from federal and state sources. The total allocation request from MTC is \$46.80M. Once approved by TVSJVRRA the request will move forward to the MTC Programming and Allocation committee on June 12, then on to the MTC Commission on June 24.

The board was also notified that a share of funding, outside of Alameda County, was identified as a partial match for this allocation. The staff of the City of Tracy has been looking at providing the project with 200 acres of land near the proposed O&M facility, with an estimated value of about \$35-40M, as a share towards the action being taken by MTC.

Chair Haggerty asked for public comment.

Discussion/Background:

The California Transportation Foundation (CTF) has announced that Alameda County Supervisor Scott Haggerty has been chosen to receive the Person of the Year Award for 2019. The prestigious award recognizes excellence demonstrated in his long career of leadership in advancing transportation infrastructure projects and the many contributions he has made to bettering the lives of all Californians. This is reflected in the many varied boards and commissions on which he has taken a leading role and serves.

Chair Haggerty is a two-time Chair of the 9-County Metropolitan Transportation Commission and has been Chair of the Alameda County Transportation Commission (and/or its predecessor agencies: ACTA, ACTIA and CMA) eleven times over the last two decades. He is credited for playing an instrumental role in the opening of the Warm Springs BART Extension and advancing the proposal for further expansion into Santa Clara County. He was a founding member of the ACE Board, the Livermore Amador Valley Transit Authority (LAVTA) and the Tri-Valley Transportation Council. He is a current Vice-Chair of the San Joaquin Joint Powers Authority. At the national level, he represents Alameda County at the National Association of Counties, where he previously served as Chairman of the Transportation Steering Committee. Most notably, he initiated the legislative proposal that resulted in the formation of the Tri-Valley – San Joaquin County Transportation Commission which is delivering the Valley Link Rail Project – and has been Chair of this Board since inception.

The California Transportation Foundation, established more than thirty years ago, is a leading charitable transportation organization in the state that supports scholarships, families of fallen transportation workers and annually acknowledges projects and people in transportation. Background/Discussion

The Regional Rail Authority continues on schedule to deliver the draft EIR for public comment in September with the plan to have the Board certify the EIR and adopt the Valley Link project by the end of the calendar year. Additional updates include:

- Operations modeling for 12-minute headways is complete and a report was provided to the Board at the May meeting. Ridership modeling and the update to 15% design are nearing completion.
- The Authority continues to work with Caltrans on the I-580 segment of the Valley Link project. In June, MTC allocated \$46.8 million to the project to fund the final approval process with Caltrans among other tasks.
- On May 28th Commissioners at ACTC voted with overwhelming support to open the 45-day comment period for member agencies in regard to the requested amendments to the Measure BB Transportation Expenditure Plan to include the Regional Rail Authority as an eligible recipient of Measure BB funds and to move the \$400 million in Measure BB funds from the BART to Livermore Project to the Valley Link Project. In September the Commissioners will consider approval of the amendments.
- The Authority will consider at the July meeting a contract award for Program Management Services, which includes general support, project control support, contract procurement and contract administration support, station architecture and sustainability support, systems and system integration and operational support. Additionally, a Request for Proposals for General Engineering Services is currently being advertised to enhance the engineering support for the project.
- The Regional Rail Authority's legal department is working closely with the City of Tracy to finalize an Agreement that will transfer title to a 200-acre property for use as the location of the Valley Link Operations & Maintenance Facilities. The property value is approximately \$40 million.

Action Requested

Approve Resolution R06-2020 of the Tri-Valley – San Joaquin Valley Regional Rail Authority supporting Valley Link and the ACE Rail Service Increase Program to be included in the fiscally constrained (before 2035) MTC Regional Transportation Plan.

Background/Discussion

Staff has been working in partnership with the San Joaquin Regional Rail Commission (SJRRC) to have Valley Link, the Altamont Corridor Vision Phase 1 and the ACE Rail Service Increase Program included in the Metropolitan Transportation Commission's (MTCs) fiscally constrained Regional Transportation Plan (RTP).

As you may recall, the Altamont Corridor Vision Phase 1 is a joint project between the Authority and the SJRRC to create a high speed alignment in the Altamont Corridor separate from freight that would be used by both Valley Link and ACE. The ACE Rail Service Increase Program includes an increase in ACE frequency between the San Joaquin Valley and San Jose and improvements to track to improve resiliency.

After evaluation of the three projects, MTC staff provided recommendations to MTC's Planning Committee on June 12, 2020. MTC staff recommended that the Valley Link project be included in the RTP, that the ACE Rail Service Increase Program be considered for inclusion, and that the Altamont Corridor Vision Phase 1 be excluded from further consideration. MTC staff have not yet identified which programs either recommended for inclusion or considered for inclusion would be part of the "before 2035" (fiscally constrained) RTP. Some of the "recommended" and "considered" programs will be relegated to being long-term projects that would be implemented after 2035. Some of the programs listed as "considered" will be recommended for exclusion from the MTC RTP.

Staff anticipates additional information from MTC in the near future that will clarify their ranking of projects and which projects have been selected by staff to be included for construction or implementation before 2035. These staff level decisions will be considered in a near future MTC Programming and Allocations Committee and then by the full Commission. Staff requests that the Authority approve Resolution R06-2020 supporting Valley Link and ACE Rail Service Increase Program to be included in the fiscally constrained (before 2035) MTC Regional Transportation Plan.

WHEREAS, AB 758 created the Tri-Valley – San Joaquin Valley Regional Rail Authority for purposes of planning, developing and delivering cost-effective and responsive transit service between the San Joaquin Valley and the Dublin/Pleasanton BART station with connectivity to ACE; and

WHEREAS, the Tri-Valley – San Joaquin Valley Regional Rail Authority Board of Directors approved a Feasibility Report as mandated by AB 758 that analyzed alternatives and selected the Valley Link passenger rail project as the preferred alternative to advance into the environmental review process; and

WHEREAS, Valley Link will carry between 26,000 and 28,000 passengers per day and reduce 33,000 metric tons of greenhouse gas emissions in 2040; and

WHEREAS, the Valley Link CEQA document is anticipated to be certified and the Valley Link project adopted by the end of calendar year 2020, with construction planned to begin as early as 2023; and

WHEREAS, ACE provides critical commuter rail service between the San Joaquin Valley and the South Bay and plans to increase service from 4 to 10 trains a day;

NOW, THEREFORE, BE IT RESOLVED that the Tri-Valley – San Joaquin Valley Regional Rail Authority Board of Directors endorses Valley Link and the ACE Rail Service

Increase Program to be included in the fiscally constrained Regional Transportation Plan and that the projects be included for construction prior to 2035.

- SUBJECT: Resolution R03-2020 Authorizing The Executive Director To Award Agreement For Program Management and Support Services

Action Requested

Staff requests that the Board of Directors (Board) authorize the Executive Director to award Professional Services Agreement No. R015 to Cole Management & Engineering, Inc. (CME) for Program Management Support Services (PMSS), in a form approved by legal counsel, for a not-to-exceed amount of \$15 million for an initial three-year period with two (2) one-year options, with issuance of Annual Work Plans (AWP) and Work Directives (WD) in excess of the Authority's current funding availability contingent upon prior approval by the Board.

Background/Discussion

Staff issued a Request for Proposals (RFP) for PMSS on June 4, 2020 so that the Valley Link project (Project) could continue progressing expeditiously as additional funding was secured. On June 11, the Authority conducted a pre-proposal conference via Zoom. A broad spectrum of sixty-two parties attended and expressed interest in the RFP. The Authority received timely and responsive submittals to the RFP on June 24, 2020 from two firms: CME and Hill International, Inc. A selection committee consisting of staff from the Authority, Bay Area Rapid Transit District (BART) and the San Joaquin Regional Rail Commission reviewed and scored the technical proposals based on the evaluation criteria contained in the RFP. The committee determined that the most qualified firm was CME.

Accordingly, the committee recommends an award under RFP No. 2020-01 to CME in an amount not-toexceed \$15 million for an initial three-year period, with two (2) one-year options. There is no minimum guaranteed amount of spending under the proposed agreement. Staff intends to issue AWP and WD that will commit specific dollar amounts to CME during the period of performance. Each AWP or WD will include a detailed work scope, schedule and budget.

On June 24, 2020, the Metropolitan Transportation Commission (MTC) approved the Authority's allocation request for \$46.8 million for the Project. Included within this request was the funding for much of the program management support services required for the project, including general support, project control support, contract procurement and contract administration support, station architecture and sustainability support, systems and system integration, operational support, as well as additional support staff from BART. Of that \$46.8 million, it is expected that approximately \$10 million will be allocated to this contract over the initial 3 year period.

Fiscal Impact

The \$15 million for the award of this PMSS agreement with CME combined with the proposed amount required for preliminary engineering services (estimated \$40 million) will exceed the Authority's current funding, including MTC's grant. Staff is actively seeking additional funding sources and recommends structuring the agreement in this way to give the Authority the ability to shift the scope of work and utilize any additional funds that may become available. CME is not guaranteed a minimum amount of work under this agreement, and the Authority will issue AWP and WD that will be verified as to availability of funding prior to issuance. Staff intends to provide quarterly updates on commitments and expenditures to the Board and will seek Board authorization prior to issuing AWP or WD that will expend funds beyond the Authority's funding availability, identifying the new fund source.

Recommended Action

Authorize the Executive Director to award Professional Services Agreement to CME for PMSS, in a form approved by legal counsel, for a not-to-exceed amount of \$15 million for an initial three-year period with two (2) one-year options, with issuance of AWP and WD in excess of the Authority's current funding availability contingent upon prior approval by the Board.

WHEREAS, the Authority prepared and issued a Request for Proposals (RFP) for PMSS in June 4, 2020;

WHEREAS, timely and responsive submittals to the RFP were received on June 24, 2020 and a selection committee comprised of Project partners reviewed and evaluated the proposals based on the evaluation criteria contained in the RFP and determined that the most qualified firm was Cole Management and Engineering, Inc. (CME);

WHEREAS, the Committee recommends an award under RFP No. 2020-01 to CME in an amount not to exceed \$15 million for an initial three-year period with two (2) one-year options; and

WHEREAS, staff will develop Annual Work Plans and Work Directives that will include a detailed work scope, schedule and budget and will be issued subject to funding availability.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Tri-Valley-San Joaquin Valley Regional Rail Authority hereby authorizes the Executive Director to award Professional Services Agreement to Cole Management & Engineering, Inc. for Program Management Support Services, in a form approved by legal counsel, for a not-to-exceed amount of \$15 million for an initial threeyear period with two (2) one-year options, with issuance of Annual Work Plans and Work Directives in excess of the Authority's current funding availability contingent upon prior approval by the Board.

- SUBJECT: Resolution R04-2020 Authorizing the Executive Director To Execute A Cooperative Agreement With The Alameda County Transportation Commission For Project Support Services of the Valley Project I-580 Segment.

Action Requested

Staff requests that the Board of Directors approve Resolution R04-2020 authorizing the Executive Director to execute a cooperative agreement with the Alameda County Transportation Commission ("ACTC").

Background/Discussion

Pursuant to the Board of Directors' approval of Resolution R02-2020 at its May 13, 2020 meeting, the Executive Director submitted a completed Initial Project Report (IPR) to the Metropolitan Transportation Commission (MTC), requesting \$46.8 million in bridge toll funds for the purposes of completing the 30% design plans, Caltrans PA&ED documents, federal environmental NEPA documents, and other operational and technical reports. Included within this request are funds to reimburse the support activities of project partners.

ACTC is a valued project partner and is a member of the Valley Link Executive Committee, which also includes BART, MTC, San Joaquin Council of Governments (SJCOG), Caltrans, San Joaquin Regional Rail Commission (SJRRC), and California State Transportation Agency (CalSTA). ACTC is also responsible for oversight of the operation and revenue collection of toll lanes and associated facilities along the I-580 corridor between Dublin/Pleasanton and Livermore. As part of the current environmental review, the Authority is evaluating the alignment of the Valley Link train route within the I-580 median between the Dublin/Pleasanton BART Station and Livermore. Discussions between the Authority and ACTC have recognized the need for ACTC's participation in the planning for the I-580 Project segment once the Project enters the 30% design phase.

The proposed Cooperative Agreement specifically focuses on reimbursing ACTC for its costs to participate in the development of the 30% design plans for the Valley Link Project along the I-580 segment of the route. ACTC provided a cost estimate of \$992,000 for the required resources to review and provide comments on the 30% design plans for the I-580 Project segment for the period of September 2020 through June 2022. This work is funded from the allocation of \$46.8 million from MTC at its June 24, 2020 Commission meeting.

Fiscal Impact

The \$992,000 for ACTC's review of 30% design plans within the I-580 project segment is included within the Authority's receipt of \$46.8 million from MTC at its June 24, 2020 Commission meeting (pursuant to Resolution R02-2020).

WHEREAS, the Authority received the allocation of \$46.8 million from MTC at its June 24, 2020 Commission meeting; and

- SUBJECT: Resolution R05-2020 Amending the Authority Budget for Receipt of Allocation of Bridge Toll Funds from the Metropolitan Transportation Commission

Action Requested

Staff requests that the Board of Directors (Board) accept the recent allocations of \$3 million and \$46.8 million in Bridge Toll funds from the Metropolitan Transportation Commission (MTC) and amend the Authority's budget to include these MTC-allocated funds for the Valley Link Project.

Background/Discussion

The Authority Board of Directors' adopted Resolutions R01-2020 and R02-2020 at its February 12, 2020 and May 13, 2020 meetings, respectively, for two allocations from MTC in the amount of \$3 million and \$46.8 million. These resolutions authorized the Executive Director to submit Initial Project Reports (IPR) to the Metropolitan Transportation Commission (MTC) to accomplish the following:

- \$3.0 million: updates to 15% design plans and California Environmental Review documents
- \$46.8 million completing the 30% design plans, Caltrans PA&ED documents, federal environmental NEPA documents, and other operational and technical reports.

MTC subsequently approved the two allocations at their March 25, 2020 and June 24, 2020 meetings. Staff recommends that the Board of Directors amend their budget to include the two allocations.

Fiscal Impact

The \$49.8 million will increase the Authority's overall budget and in accordance with the allocation from MTC these funds will be dedicated to advance the planning and design of the Valley Link Project.

WHEREAS, on March 25, 2020 the Metropolitan Transportation Commission allocated \$3 million to the Authority for the Valley Link Project for the purposes identified in Authority Resolution R01-2020; and

WHEREAS, on June 24, 2020 the Metropolitan Transportation Commission (MTC) allocated \$46.8 million to the Authority for the Valley Link Project for the purposes identified in Authority Resolution R02-2020; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Tri-Valley-San Joaquin Valley Regional Rail Authority hereby accepts the allocations of \$49.8 in Bridge Toll funds from the Metropolitan Transportation Commission and amends the Authority's budget to include these allocated funds for the Valley Link Project.
